#### **Work Picture**

We have between 30 and 40 mechanics on the open employment list and less than 5 to 10 apprentices. We also have around 60 Assistant Mechanics working. Over the past couple of years, Local 18 has maintained between 2300 and 2400 members. Las Vegas has projects winding down and any transients working in that area have been sent back to their locals. San Diego has steadied without much hiring expected in the sub-primary this month. The Assistant Mechanics list continues to grow, as apprentices are completing their courses and passing the Mechanics Exam. The independent companies have been picking up Modernization jobs and expect to be hiring soon; a couple of majors are also projecting a need for labor soon.

#### **Belt Monitoring Devices**

Please review this <u>Circular Letter</u> regarding Coated Steel Belt Monitoring. There have been reports of belt failures causing catastrophic damage to the elevator equipment. If unsafe practices continue, it is a matter of time before an accident involving our members or the riding public will occur. When this product was introduced in the industry, manufacturers estimated about a fifteen-year life span of these belts. We are in the time frame of the expected life span for many of these units, thus making your inspections critical. Furthermore, a belt monitoring device is required to be in place and operating properly. Do not compromise safety when faced with overriding any safety device, circuit, or inputs in a microprocessor.

#### MyLink allows you to:

- Opt-In to the IUEC texting program.
- View and update your contact information and address.
- View your Benefit Hours.
- Sign and submit documents such as Dues Check Off Authorization, Withdrawal Request, etc.
- View documents specific to your local, such as, Local Constitution & Bylaws, Local Expense Agreements, Local Jurisdiction, etc.
- View your NEIEP apprentice course history and Continuing Education history.

#### **Union Working Cards**

As we approach the 3<sup>rd</sup> month of the quarter, there are still members working without a Union Working Card. Please continue to check Union Working Cards. If you are a member without a current Union Working Card, you must contact an Agent immediately.

#### **Medical List**

As a member, it is a requirement to keep the hall current with your status. With that, if you go out of work for medical reasons, you are required to contact the hall, as there is benefit paperwork that must be filled out. As a reminder, if you are out of work due to medical reasons, you are not required to pay local dues; by contacting the hall, the necessary paperwork will be completed, your status will be updated, and you could be entitled to an adjustment in your current quarter's dues. Lastly, once you are released to return to work, please provide the hall with a doctor's release note and we will update your status.

#### **Continuing Education**

If you complete your Mechanic Exam after July 9, 2022, you must complete 8 hours of Continuing Education each calendar year, regardless if you are on an Assistant Mechanic Agreement. NEIEP has created an online course and it is available at NEIEP.org. Once you have completed the course, you will receive 8 hours of the local mechanic rate.

#### 9 Safety Absolutes

#### ELEVATOR INDUSTRY BEST PRACTICES TO MAXIMIZE SAFETY & PREVENT INJURIES

#### 1. CAR TOP ACCESS

Always maintain control of car; use door lock and stopper correctly; verify door safety and all switches independently; ensure stop switches are activated when exiting car top; secure working area.

#### 2. PIT ACCESS

Always maintain control of car; use door lock and stopper correctly; activate and verify pit stop switch; use ladder safely; turn on pit light; deactivate stop switch after exiting; secure working area.

### 3. MECHANICAL STORED ENERGY

Bring equipment to zero energy state; avoid pinch points; do not wear loose clothing and be careful when wearing gloves; ensure all loads are stable and secure; do not put yourself in the line of fire.

#### 4. FALL PROTECTION

Always wear proper personal protective equipment and tie off when a fall hazard exists; inspect your fall protection system every time; be aware of your surroundings; ensure proper guardrails are used.

#### 5. FALSE CARS & RUNNING PLATFORMS

Perform inspection of equipment prior to use; operate with at least two means of safety; always assemble/disassemble at the lowest landing; do not overload; install a protective barrier between cars.

#### 6. HOISTING & RIGGING

Ensure hoisting & rigging plan is in place; know the weight of the load and that equipment is rated appropriately; do not stand or walk under hoisted load; use certified equipment & inspect before each use; ensure load will clear all obstructions.

#### 7. **JUMPERS**

Do not install jumpers on the safety circuit when elevator is on automatic operation; only use company approved jumpers and inspect prior to use; account for all jumpers at all times; always notify co-workers jumpers are being used; use a jumper tag; understand how your jumpers will affect the entire system.

#### 8. ELECTRICAL SAFE WORK PRACTICES

Lock out and tag out if power is not required; test meter on known source before use; probe with one hand to verify circuits; use certified tools; inspect before each use and prevent incidental contact; always protect high voltage exposed live circuits.

### 9. LOCK OUT / TAG OUT

Ensure there are no passengers and cab is secure; lock out and tag out (LOTO) if power is not required; follow company LOTO procedures; verify the correct system has been de-energized; follow electrical safe work practices.
